## Membership Detail

**Family Membership**-For married families and their immediate family members and includes all amenities of the club including golf, driving range, clubhouse and swimming pool.

**Individual Membership**- For individuals (married or unmarried) and includes all amenities of the club including golf, driving range, clubhouse and swimming pool. Amenities are for the individual member only.

**Senior Membership**-For married or unmarried individuals age 65 and over and includes all amenities of the club including golf, driving range, clubhouse and swimming pool.

**Social Membership**- For families or individuals and includes clubhouse, swimming pool and a limited number of rounds of golf. Does not include practice range privileges.

**Non-Resident Membership**-For families or individuals who maintain a second residence for at least six months out of the year or a primary residence that is at least 30 miles from Jackson, Missouri and includes all amenities of the club including golf, driving range, clubhouse and swimming pool.

**Junior Membership**-For for families or individuals age twenty nine (29) years or under and includes all amenities of the club including golf, driving range, clubhouse and swimming pool. For families, the age of the oldest spouse will determine eligibility. Upon reaching age 30 juniors can continue membership on a sliding dues scale until they reach age 35.

## Initiation Fees

A one-time initiation fee of \$750 (plus tax) is payable along with your initial membership dues. If you continue your membership the fee is returned in the form of a dues credit during membership years two and three. Kimbeland rents golf carts for \$15.00 per person (18 holes). Annual leases are available for \$475.00 (plus tax). Cart sheds are available for a \$250 annual rental fee if you prefer to have a privately owned golf cart.

## Payment Schedules and Information

Membership dues are billed in advance. Membership dues can be paid annually, semi-annually, quarterly, or in some cases monthly. Annual dues are billed on January 1<sup>st</sup> of each year. Service charges apply to those paying quarterly or monthly. Quarterly statements are mailed for quarterly and semi-annual accounts. Due dates are as follows:

Annual	January 31 <sup>st</sup>
Semi-Annual	January 31 <sup>st</sup> and July 31 <sup>st</sup>
Quarterly	January 31 <sup>st</sup> , April 30 <sup>th</sup> , July 31 <sup>st</sup> , Oct 31 <sup>st</sup>

Additional service charges may be added to membership accounts for dues not paid by the due date.

Memberships are for a calendar year and accordingly you are responsible for dues for the entire year in which you join or renew your membership. Membership can be cancelled on or before January 31<sup>st</sup> of each year thereafter.

**Your signature below indicates you understand and agree to this provision of the club rules and regulations.**

Monthly restaurant minimums of fifteen (\$15) dollars are assessed March thru November of each year. Members must spend the monthly minimums each month in the restaurant or they are billed for them adjusted by any amounts spent during the month. Minimums do not apply November thru February. Minimums do not apply to junior or non-resident memberships.

Kimbeland Country Club is owned by Jackson Country Club, Inc. Owning a share of stock entitles the member to a \$5.00 discount on their annual dues plus sales taxes do not apply to your annual dues. Purchase of stock is based on availability. Stock can be purchased for \$100.00. A sale restriction contract is required to be completed prior to purchasing a share of stock.
